When selecting façade building membranes for projects across the UK - architects, specifiers and main contractors should take extra precautions to ensure that the correct system is selected.

Regulatory updates to Approved Document B (for England and Wales) which are now in force, mean that any membranes applied to the external walls should achieve a minimum fire classification of B-s3, d0 in accordance with EN 13501-1 for relevant, complex or high risk buildings buildings across England & Wales.

Whilst it is important to remember that membranes are not designed to be fire stopping material or fire breaks and as such are also not currently required to achieve a Class A1 or A2,s1, d0 rating – any membrane installed should meet the requirements of the relevant national Building Regulations.

Our range of fire rated (FR) breathable membranes and vapour control layers allow designers to optimise the weather protection and level of air tightness confidently using a range of solutions from illbruck, meeting even the most demanding applications where fire safety is critical.

In the UK, BS EN 13501-1, has become the standard reference in the Building Regulations for classifying the minimum reaction to fire performance for all building materials used in the external envelope of a building.

For a relevant building in England and Wales, the current Building Regulation requires that the materials which become part of an external wall area to be Euroclass A2-s1, d0 or A1.

As the façade plays a critical function within the design of a building, it is always the recommendation of illbruck that architects and specifiers use a system which is compliant with UK Building Regulations.

Our recently launched range of FR membranes ensures that there is a suitable solution for all applications - all available from a single source supplier.

Under the Building Regulations Approved Document B, membranes used as part of the external wall construction above ground level should now achieve a minimum of Class B-s3, d0 to EN 13501-1 'Fire classification of construction products and building elements. Classification using test data from reaction to fire tests.'

The European reaction to fire classification (Euroclass) system is the common EU standard for assessing the performance of building materials when subject to fire. The performance of all illbruck systems is determined by measuring a comprehensive set of characteristics, including ignitability, flame spread, heat release, smoke production and tendency for producing flaming droplets/particles.


