Substrate Preparation

Surfaces must be dry and free of oil, grease, dust and other contaminates that may negatively affect the bond strength. Bonding to frozen surfaces is not possible.

Remove the release paper and place ME355 centrally over the membrane joint. A minimum coverage onto each substrate of 30mm is recommended.

Press the adhesive tape onto the surface by hand or with a pressure roller without leaving any creases.

Overlaps should always be made in the direction of water flow.
