SECTION 4: First-aid Measures

4.1 **Description of First Aid Measures**

GENERAL NOTES: Show this safety data sheet to the doctor in attendance.

AFTER INHALATION: Move to fresh air. Give oxygen or artificial respiration if needed. When risk of unconsciousness, place and transport the victim in secured recovery position. 5.2 Special hazards arising from the substance or mixture

Heating or fire conditions liberates toxic gas. Flash back possible over considerable distance. As the product contains combustible organic components, fire will produce dense black smoke containing hazardous products of combustion (see section 10). Vapours may form explosive mixtures with air. Solvent vapours are heavier than air and may spread along floors and ignite.

5.3 Advice for firefighters

7.1 Precautions for safe handling

Additional Information:

This product may contain Ethyl Benzene, which is listed by IARC as possibly carcinogenic to humans (Group 2B). This listing is based on inadequate evidence of carcinogenicity in humans and sufficient evidence in experimental animals. Chronic exposure causes drying effect on the skin and eczema. Repeated or prolonged skin contact may cause allergic reactions with susceptible persons. Repeated skin contact leads to irritation and to sensitisation, possible with cross-sensitisation to other epoxies. Chronic exposure has been associated with various neurotoxic effects including permanent brain damage. The product is irritating to the eyes and may cause sensitisation to the respiratory system.
