SECTION 4: First-aid Measures

4.1 Description of First Aid Measures

GENERAL NOTES: When symptoms persist or in all cases of doubt seek medical advice. Show this safety data sheet to the doctor in attendance.

AFTER INHALATION: Remove person to fresh air. If signs/symptoms continue, get medical attention.

SECTION 5: Firefighting Measures

5.1 Extinguishing Media:

Carbon Dioxide, Dry Chemical, Foam, Water Fog

SECTION 7: Handling and Storage

7.1 Precautions for safe handling

Wear personal protective equipment. Avoid contact with skin and eyes. Apply technical measures to comply with the occupational exposure limits (see section 8).
